8. I don't throw garbage anywhere, not just in the classroom. I politely warn my friend who throws garbage on the ground. If I find garbage, I throw it in the trash.
9. I don't turn on the lights unnecessarily, not only in the classroom, but anywhere. I turn off the wasted lights.
10. I'm looking for the owner of an item I found on earth. If I can't find it, I put it in the box for finds in the classroom.

How are the class rules determined?

The rules of behavior in the classroom should be prepared after the introductory period of students. Students can be formed together after they get used to the school, the teacher, their friends and the environment. If you want the desired order and behavior to be achieved in the classroom,

you must involve students in setting the rules. The rules that students do not agree with and do not accept will remain only on paper.

The teacher should explain the reasons why certain rules should exist in the collective environment. Taking into account the elements of love, respect and tolerance, it is necessary to explain which behavior is wrong. You can also make sure that the consequences of such behavior are taken into account.

After the teacher has finished speaking, he or she can ask the students what rules they should set in the classroom. It is best to write these points on a blackboard on a blackboard. The teacher should leave his ideas for last. After students have defined the rules, the applicability of each rule should be discussed.

After all the rules are defined, they should be posted on the board in writing. Every student should also know that he follows the rules. You can also give a list of class rules to parents and force them to follow. You should be careful when setting the rules in class in writing in junior high and verbally in high school.

We can list the importance of class rules as follows;

4. Depersonalizes rewards and punishments and makes them acceptable.
- 5-It makes the classroom environment more efficient.
- 6-Noticeably reduced bad behavior due to control.

**Considerations when setting class rules.** The teacher should not be the one to set the rules in the classroom. This should be determined with the participation of the students and to the extent applicable. The system of rewards and punishments should be clearly defined. This is necessary so that each student understands that everyone is equal to each other.

In conclusion, based on all of the above, we can conclude that the rules of behavior in the classroom are necessary in school life. And in order for students to follow them, the joint work of the teacher, students, as well as their parents is extremely important.
